CAPCOA releases Clean Air Progress Report 2014

California Air Pollution Control Officers' Association summarizes progress toward cleaner air as well as challenges that remain in meeting health-based air quality standards

On April 23, the California Air Pollution Control Officers' Association (CAPCOA) released its annual California's Progress Toward Clean Air report. CAPCOA represents the 35 local air districts throughout California. The air quality statistics in the 50-page report document an ongoing trend of air quality improvements across the state.

According to the report, "These improvements occurred while population and vehicle miles driven in California continue to grow steadily. Over the last 20 vears, California's population increased by 22 percent and average daily miles driven increased by 45 percent. Over the same time, statewide emissions of smog-forming pollutants decreased by over 50 percent. These substantial reductions in harmful air pollutants are the result of a comprehensive air pollution control strategy implemented by local Air

Districts and the State of California."

The report goes on to say that cars and trucks emit significantly fewer air pollutants than they did 20 years ago. It adds that



emissions reduced due to incentive and grant programs have expedited the turnover in California's vehicle fleet, where older and more polluting heavy duty vehicles are either retrofitted to make them cleaner or are taken off the road altogether. In addition, Air Districts have adopted and implemented numerous regulations and strategies that have effectively reduced industrial source emissions.

But the report also outlines many challenges, including the likelihood of evermore stringent state and federal air quality standards. The report quotes the World Health Organization which recently stated that air pollution kills about seven million people worldwide every year, equating to about one in eight deaths being attributable to breathing bad air.

The report also mentions the climate change factor. "While dramatic progress has been made in reducing air pollution and meeting air quality standards over the years, the effects of climate change threaten to reverse this progress and (Continued on Page 3)

diminish decades of investments made to improve air quality. The higher number of extreme heat days and heat waves predicted to occur as a result of climate change will increase smog formation, increase the number of and severity of wildfires, worsen heat island effects in urban areas, and increase adverse health effects due to the public's increased exposure to air pollutants. . . As climate change raises new air quality challenges, Air Districts will need to continue stepping up by pursuing new rules and regulations and developing programs to address greenhouse gas emissions and other air pollutants." The report discusses how the Districts will address these challenges in a section called "California's Comprehensive Air Quality Strategy." from California's Progress Toward Clean Air 2014

Ventura County Air Pollution Control District excerpts

- Ventura County continues to make great progress towards meeting the federal 0.075 ppm 8-hour ozone standard as evidenced by a steady decadeslong decrease in 8-hour ozone design values. In 2003, Ventura County's 8-hour design value was 0.095 ppm. Likewise, over that same period, the number of days over the federal 8-hour ozone standard declined from 68 days in 2003 to only 4 days in 2013, making 2013 the County's cleanest, most smogfree year on record.
- Of course, the Air District must continue working to further reduce air pollutant emissions in Ventura County to reach all state and federal clean air standards. To achieve that goal, the Air District must not only focus its efforts on reducing smogforming emissions from stationary sources as it has for many decades, but must also address emissions from mobile sources as well.

- Two of the Air District's most notable mobile source strategies that are helping Ventura County reach healthful air quality levels are its Carl Moyer and Plug-In Electric Vehicle (PEV) Programs.
- The Carl Moyer Program encourages owners of equipment with old, high polluting engines to replace their equipment with newer, much cleaner engines. Since 1998, the Air District has awarded nearly \$28 million in grants to replace 828 highpolluting engines with much cleaner, fuel efficient engines thereby ridding Ventura County's air of smog-forming pollutant, toxic particulate matter, and greenhouse gases beyond those achieved by the Air District's traditional clean air programs.
- Over the last three years, the Air District's PEV program has been actively supporting the rollout of electric vehicles in the County.
- As in previous years, 2013 was an active year for the Air District's public information and outreach programs that educate County citizens about air quality, the health effects of air pollution, and actions individuals can take to improve the air.

Get UV prepared for summer.

While some exposure to sunlight can be enjoyable, too much can be dangerous. Overexposure to ultraviolet (UV) radiation from the sun can result in a painful sunburn. It can also lead to more serious health problems, including skin cancer, premature aging of the skin, cataracts and other eye damage, and immune system suppression. Children are particularly at risk. Most people are not

aware that skin cancer, while largely preventable, is the most common form of cancer in the U.S. More than 3.5 million new cases are diagnosed annually. By following some simple steps, you can still enjoy your time in the sun and protect yourself from overexposure.

- Do not burn.
- Avoid sun tanning and tanning beds.
- Generously apply sunscreen with a Sun Protection Factor (SPF) of at least 30. Reapply

every two hours, even on cloudy days.

- Wear protective clothing.
- Seek shade when possible.
- Use extra caution near water, snow and sand. Check UV Index forecast issued daily by the National Weather Service and U.S. EPA.
- Get Vitamin D safely through supplements and foods fortified with the vitamin. (Source: United States EPA)

FOCUS on climate change

District tallies informal, non-scientific student poll on climate change

At the Science, Technology, Engineering & Math (STEM) Career Day at the Ventura County Fairgrounds on March 19, District staff asked 100 middle and high school students from various County schools to respond to 12 statements about climate change with five ratings from strongly agree to strongly disagree. This was for information purposes only and does not represent a formal, scientific research sampling; it is just an informal poll of 100 random students. Here are some of the findings.

I have learned something about climate change in school. - **strongly agree - 43**%

I believe climate change is happening. – **strongly agree – 67.5**%

I have read something about climate change in the past year. - strongly agree - 50%

I think climate change is not really that important in my life. – **strongly disagree** – **52.5%**

I think climate change is not going to impact my future. - strongly disagree - 57.5%

I think climate change can cause a lot of problems like heat waves, droughts, declining fish and wildlife, and health problems. – **strongly agree – 40%**

I think there are many actions people can take to reduce climate change. – **strongly agree** – **43**%

I, personally, would do some actions to reduce climate change like considering purchasing an electric car. – **strongly disagree** – **22.5**%

I believe climate change should be a high priority for the President and Congress. – **strongly agree – 30%**

I think there is agreement among scientists about climate change. – **strongly disagree** – **31%**

I want the state government to pass regulations and spend money now on efforts to prepare for the effects of climate change such as flooding, storms, and wildfires. **Neither agree nor disagree – 30**%

I am convinced that humans will successfully reduce climate change. – **strongly agree** – **20**%

Advisory Committee

The Ventura County Air Pollution Control District (VCAPCD) Advisory Committee will meet to consider proposed amendments to Rule 26.13, New Source Review - Prevention of Significant Deterioration. Staff is proposing revisions to include updates required as a result of court decisions and clarifications regarding enforceability and responsible parties. New requirements address interagency notification requirements, application completeness determination, and applicant notification requirements. In addition, new subsections address greenhouse gas requirements and options for PSD permitting of power plants regulated by the California Energy Commission. The public participation requirements are also expanded and clarified in the proposed revisions.

The Advisory Committee meeting will be held on June 24, 2014 at 7:30 p.m. in the Large Conference Room at 669 County Square Drive, Ventura.
