New report from the Intergovernmental Panel on Climate Change

From Copenhagen, November 2, 2014

new report from the Intergovernmental Panel on Climate Change (IPCC), released November 2, concludes that human influence on the climate system is clear and growing, with impacts observed on all continents. If left unchecked, climate change will increase the likelihood of severe, pervasive and irreversible impacts for people and ecosystems. However, options are available to adapt to climate change and implementing stringent mitigation activities can ensure that the impacts of climate change remain within a manageable range, creating a brighter and more sustainable future.

These are among the clear findings of the Synthesis Report that distills and integrates the findings of the IPCC Fifth Assessment Report produced by over 800 scientists and released over the past 134 months, the most comprehensive assessment of climate change ever undertaken. The IPCC is

the world body for assessing the science related to climate change. It was set up in 1988 by the World Meteorological Organization and the United



Nations Environment Programme to provide policymakers with regular assessments of the scientific basis of climate change, its impacts and future risks, and options for adaption and mitigation.

The Synthesis Report confirms that climate change is being registered around the world and warming of the climate system is unequivocal. Since the 1950s many of the observed changes are unprecedented over decades to millennia. The report expresses with greater certainty than in previous assessments the fact that

emissions of greenhouse gases and other anthropogenic drivers have been the dominant cause of observed warming since the mid-20th century.

The impacts of climate change have already been felt in recent decades on all continents and across the oceans.

The more human activity disrupts the climate, the greater the risks. Continued emissions of greenhouse gases will cause further warming and long-lasting changes in all components of the climate system, increasing the likelihood of widespread and profound impacts affecting all levels of society and the natural world, the report finds. Some tips for a "green" holiday



Recycle wrapping paper, or better yet, forgo it altogether. Try making your own wrapping paper and trimmings from newspapers, paper bags, art projects, clothes, dish towels,

etc. If you do buy new wrapping paper, go for the kind without glossy metallic coating, which makes it harder to recycle.

Celebrate at home. Much of the worst impact to the environment comes from all the carbon dioxide emitted by the transportation we use to get around during the holidays. Consider limiting your plane travel (the worst offender) and long car rides. If must use the car, be sure and carpool.

Lose the lights. Think about cutting back on excessive house and yard lights. And if you are decorating with lights, try switching to the LED

variety, which can use 90 percent less energy than regular holiday lights.

Buy in bulk. Instead of purchasing cans of soda, small bags of chips, and serving-size baking supplies, stock up on bulk goods to reduce packaging waste.

Use real dishes. While disposable plates and silverware are easier if you're hosting crowds, the environment will thank you if you buck up and do the dishes.

Use a real tree, and then recycle it when it's done! Though it may feel sad to cut down a tree for the holidays, consider that most Christmas trees are grown expressly for the purpose (so you're not contributing to deforestation), and can be planted or composted when you're done with them. Plastic trees, in contrast, require petroleum to make, and then can't be recycled easily when you're through with them.

APCD Advisory Committee

On October 28, 2014, the APCD Advisory Committee met to consider proposed new Rule 74.33. This rule will reduce reactive organic compound (ROC) emissions associated with the transfer and dispensing of liquefied petroleum gas (LPG).

This rule, which is based on South Coast Air Quality Management District (SCAQMD) Rule 1177, will apply to the transfer of LPG to or from any cargo tank, any stationary or portable tank, or any cylinder, with the exception of LPG cylinders installed on recreational vehicles. Also, the proposed rule would not apply to the transfer of LPG into any container having a water capacity of less than four gallons. In addition, this new rule will not apply to oilfield LPG tanker truck loading facilities subject to both Rule 71.3, Transfer of ROC Liquids, and Rule 74.10, Components at Crude Oil and

Natural Gas Production and Processing Facilities.

This proposed rule will implement an All Feasible Measures requirement of the California Clean Air Act (Health and Safety Code Section 40914). There have been no changes to the proposed rule since the August 21, 2014 public workshop.

The Advisory Committee recommended that the Air Pollution Control Board approve proposed new Rule 74.33. The rule is tentatively scheduled to be considered for approval by the Air Pollution Control Board on January 15, 2015. 




Ozone Report

The maximum 1-hour average was 0.112 ppm at El Rio; the maximum 8-hour average was 0.084 ppm at Simi Valley.





