Cash for polluting cars



oluntary accelerated vehicle retirement, or VAVR programs, have been operating in California since the 1990's. VAVR programs are sometimes referred to as car scrappage or vehicle buy back programs and are designed to provide incentives, including monetary payments, to owners of older, more polluting vehicles to voluntarily retire their vehicles. The Ventura County Air Pollution Control District currently does not have a local program, but County residents can take advantage of the Bureau of Automotive Repairs (BAR) Consumer Assistance Program. (Note, the State of California and the Air Resources Board (ARB) do not administer the program.)

If your vehicle **failed** its last Smog Check, the BAR's Consumer Assistance Program may pay up to \$1,000 to retire your qualified vehicle. Consumers can receive payment to retire their high-polluting vehicle. There are no income or directed vehicle eligibility requirements. Approved applicants must take their vehicle to an authorized dismantler. The vehicle must pass a visual and operational inspection before it is retired.

How to apply

You can obtain the CAP application at

www.smogcheck.ca.gov, and click on the Consumer Assistance Program. Or you can call the Department of Consumer Affairs Consumer Information Center at 800-952-5210. If you applied for vehicle retirement, you will receive an approval letter and a list of contracted dismantlers.

Into the future

There is also a new vehicle scrap program that is currently being developed by ARB in consultation with the Bureau of Automotive Repair called the *Enhanced Fleet Modernization Program*.

This program will provide new funding, roughly \$30 million dollars annually through 2015 to expand the State's existing voluntary vehicle retirement program. The Bureau of Automotive Repair will begin administering the program beginning January 1, 2010.

There are two main features of the proposed program. First, the proposal would significantly expand the

existing statewide program by removing the requirements that vehicles be subject to Smog Check and fail the emissions test to participate. Second, additional compensation would be made available to targeted consumers in areas with the most severe air quality problems to incentivize the retirement of probable gross polluting vehicles along with

the purchase of newer, cleaner vehicles. It is proposed that compensation range from \$1,000 for a basic retirement up to a maximum of \$1,500 total for retirement and replacement voucher. The program is structured to provide extra funding and flexibility to low-income participants.

March APCD Board Meeting highlights. At its March 10 meeting, the following items were approved:

√ **Supervisor Kathy Long** recognized **Keith Duval** as the new Deputy Air Pollution Control Officer.

√ **Cameron Williams** appointed to the APCD Advisory Committee as a representative for Supervisorial District III. **James Tovias** appointed to the APCD Advisory Committee as a representative for City of Santa Paula.

√ On the occasion of his retirement, **Supervising Inspector Larry Scott** recognized by the Board for 38 years of service.

√ Approved and adopted the proposed statutory findings and CEQA Notice of Exemption for proposed amended Rule 70, Storage and Transfer of Gasoline. (April Skylines, Rules section).

√ Authorized the District to request the U.S. Environmental Protection Agency make a determination that **Ventura County has attained the federal one-hour ozone standard**. This would clarify that major sources in Ventura County are not subject to federal Clean Air Act Section 185 (nonattainment) fees.

√ Received and filed unaudited financial status report for FY 2008/09.



Earth Day 2009 in Oxnard. On April 4, the District had an air quality display at the City of Oxnard's annual Earth Day Celebration in Plaza Park. Over 600 people stopped by the booth to get air quality information and to spin the Clean Air Wheel.

Springtime is also allergy time. And, according to a new study, researchers link exacerbation of childhood allergies to increased air pollution. A survey of more than 70,000 children, aged three to 17, revealed that exposure to greater amounts of ozone or particulate matter triggers more symptoms of hay fever and respiratory allergies.

The study results, published in the January 2009 issue of Environmental Health Perspectives, found that for even small increases in the ambient amount of ozone or particulate matter, the population of children could expect a significant increase in the likelihood of hay fever and respiratory allergy symptoms. In California, the Air Resources Board estimated that one million school absences are associated with ozone exposure alone. (source: Air Resources Board news release, 3/26/09)

am happy to report that the District's Global Climate Change Outreach Presentation is still going strong. Since January 2008, I've spoken to 550 people at 21 events: the response has been overwhelming positive. Things change surprisingly quickly in the climate change universe, so I am constantly updating the presentation. The EPA Climate Change Web Page changed recently, and the California Air Resources Board is making steady progress in its implementation of the Global Warming Solutions Act of 2006. It seems like new information becomes available daily, and I do my best to keep up with the changes. For example, the Federal Stimulus Package, or the American Recovery and Reinvestment Act, includes a number of energy efficiency and renewable energy programs. Among these, \$300 Million has been set aside nationwide for rebates on Energy Star appliances. The U.S. Department of Energy is offering grants for research on both electric

into electricity. Each time you pass through vehicle battery manufacturing and transportation electrification.

Some groups have requested an extended discussion, so I've prepared both 40 minute and 20 minute presentations. The extended presentation includes the pros and cons of various technology solutions currently in use or under development. Both presentations discuss climate change issues around the world, federal, state and local activity, and things we all can do to reduce the effects of global climate change.

Advisory Committee

Paved Roads and Public Unpaved Roads and Certified PM-10 Street Sweeping Equipment (Rule 55.1 and Rule 55.2 – New): On April 28, 2009, the District Advisory Committee will consider two proposed new rules to reduce particulate matter (PM) emissions. Ventura County fails to meet the state standard for PM air quality, and a 2003 state law (SB 656) mandated that the District adopt new regulations to reduce PM air pollution.

Proposed Rules 55.1 and 55.2 will implement PM control measures adopted by the Board on June 28, 2005, but not included in the recent adoption of Rule 55, Fugitive Dust. Although the proposed rules are based on South Coast AQMD Rule 1186, not all requirements from that rule are being proposed.

Public Consultation Meetings

Emissions Banking for Agricultural Pump Engines (Rule 26.4.1 - new): On August 12, 2008, District staff held a public consultation meeting to discuss the development of a new rule that will establish a procedure for banking surplus agricultural pump engine emission reductions. These engines are currently exempt from the requirement to hold a Permit to Operate.

Emission banking will be allowed only when fuel use and hours of operation data is available and may require a restrictive covenant to ensure that banked emissions are permanently reduced. The proposal expands on the requirements of Rule 26.4, Emissions Banking, which is part of Rule 26, New Source Review. The EPA has stated that agricultural pump engine emissions reductions will not be recognized unless Rule 26.4.1 (or a similar proposal) is adopted.

Recent Board Actions

Permit Fees (Rule 42 – Revised): On April 14, 2009, the Air Pollution Control Board adopted amendments to Rule 42. The revisions include a 3.5 percent increase in permit renewal fee rates, effective July 1, 2009. For permit holders paying the minimum fee, this revision will result in a fee increase of \$16.00 per year. The Board also adopted an hourly fee for the processing of Title V Permits to Operate and a revision to the 'transfer of ownership' fee.

District operations are funded by state and federal grants, automobile registration fees, and fees charged to sources of air pollution. The APCD receives no property tax revenue or general fund revenue. The fee increase is necessary to offset rising expenses. Storage and Transfer of Gasoline (Rule 70 - revised): On March 10. 2009, the Air Pollution Control Board adopted amendments to Rule 70. The revisions include:

- An exemption from Phase II enhanced vapor recovery for fleets equipped with Onboard Refueling Vapor Recovery (ORVR);
- An exemption from Phase II for E85 fueling facilities;
- A restriction on standing gasoline in Phase I spill containment devices;
- A requirement for daily hanging hardware inspections; and,
- A requirement to submit test results within 14 days.

Motor Vehicle and Mobile Equipment Coating Operations (Rule 74.18- revised): On November 11, 2008, the Air Pollution Control Board adopted amendments to Rule 74.18. The revisions are based on a Suggested Control Measure (SCM) adopted by the California Air Resources Board on October 20, 2005.

As a non-attainment area for both federal and state ozone air quality standards, Ventura County is required to adopt all feasible measures, such as the SCM, to reduce reactive organic compound emissions. Motor Vehicle and Mobile Equipment Coating Operations (Rule 74.18 – Revised): Revisions to the coating ROC content limits in Rule 74.18 become effective on January 1, 2009, except for the following coating categories, which become effective on January 1, 2010:

- Adhesion Promoter
- Primer Sealer
- Single-Stage topcoat

Color coatings, as part of a basecoat/clearcoat system, which exceed the new 420 grams per liter limit and have been manufactured prior to January 1, 2009, may be sold and applied until July 1, 2009. The new low-ROC cleaning requirement at 25 gram per liter and a new limited-use surface preparation exemption become effective on January 1, 2010. Surface Coating of Metal Parts and Products (Rule 74.12 – Revised): Revisions to Rule 74.12 become effective 90 days after adoption, or July 8, 2008. The revisions include a lower ROC limit for general air-dry one-component coatings (2.3 lb/gal) and a new multi-component coating category at 2.8 lb/gal. In addition, a requirement to use cleanup solvents with an ROC content of no more than 25 grams per liter (g/l), or 0.21 lb/gal, becomes effective. 
Registration of Agricultural Engines (Rule 250): The California Air Resources Board (ARB) has finalized new regulations for diesel engines used in agricultural operations. In general, these regulations apply to nearly all diesel engines used to power irrigation pumps; however, they will not apply to diesel engines used to power farm equipment such as trucks and tractors. The new regulations have both administrative requirements and emission control requirements. 
To implement the state agricultural diesel engine regulations, the District adopted Rule 250, "Registration of Agricultural Engines" on September 11, 2007. The rule establishes a diesel engine registration program with a deadline of March 1, 2008. The registration program is not a permitting program, but requires application forms and fees similar to a permitting program. The fees are significantly less than permitting fees and are specified in Rule 48. Both rules appear on the District's website noted above.


